Dear Peekskill Families,

Our present and future reality is unprecedented for our generation. I think we can all agree that the last few weeks have been replete with uncertainty and challenges. Decisions are being made at a rapid pace in conjunction with the professional medical guidance we receive and the mandates from the State Education Department, County leaders and the Governor's office. As we begin a new month, I encourage everyone to continue moving forward as best as we can under these circumstances. I know that we have all had to adjust to our roles that include maintaining our households; supporting the education of our children; caring for our family; working from home; social distancing; physical activity; emotional wellness and a variety of other important daily tasks. As a district, we understand that everyone is adjusting to these constant changes in their own way and at their own pace. There is no single formula that works for every family, and with that said, I remind everyone to continue making the decisions that are best for you and your family. While it is critical that our students remain engaged in learning, let us also not forget to nurture the physical and emotional well-being of ourselves and loved ones.

# NYS Directives Regarding Continued Learning Through April 15

On March 27, 2020, Governor Cuomo issued Executive Order 202.11, which extended the time schools would be closed through April 15, 2020. In that Executive Order, Governor Cuomo stated that all schools must now use any scheduled vacation/snow days for remote learning. The Deputy Secretary of Education clarified that this Order includes the upcoming spring break week, which our District had previously scheduled for April 6-10. The consequence of failing to abide by this mandate would force our District to forfeit the State Aid we would normally receive for each of those days, and further put Peekskill at risk of losing aid for all of the days included in our COVID-19 closures. If we incur this loss of aid, it would result in a devastating impact on our District's 2020-21 budget.

Therefore, in compliance with the Governor's order, next week will continue to be a week of distance learning for students. I also want to be sensitive to the religious implications for many of our families during this week, so once again, I encourage you to organize your home-schooling schedule in a fashion that works best for your family.

Among other items addressed, the Governor has also directed that any school board elections scheduled to take place in April or May of 2020 are postponed until at least June 1, 2020. Further guidance on this topic, as well as for our annual budget vote, will follow once we receive additional directives from the State.
