     The meeting was reconvened in the Ford Auditorium.

Comments were made from residents regarding the Superintendent and the allegations from Judge Johnson regarding something to the effect of the resignation of the Superintendent. How are children to relate to someone who violates the law and the oath to serve the community? They would like to know what is the Board planning on doing about the situation. There seems to be a discrepancy between what is in the newspapers and what was said this evening.

President Simpkins read a statement on behalf of the Board in the hopes of clarifying news report mentioning the Superintendent. The Board along with legal counsel, has met with Dr. Mauricio to understand the circumstances of a traffic ticket dismissal received by the Superintendent. In the spring of 2023, Dr. Mauricio was contacted by the New York State Judicial Commission and Professional Ethics to discuss the dismissal and Dr. Mauricio fully cooperated with the Commission. This was the first time he was aware of the dismissal of the traffic ticket. He was told by the Judicial Commission of Professional Ethics, not to reveal any information during the investigation to anyone. Once the investigation was concluded, he fully disclosed to the Board what had transpired. The Board fully understands the

circumstances concerning the ticket and the nuances that have not previously been made public. After visiting the court in person to schedule a court date, Dr. Mauricio was informed it may be months, before he would receive a court date. After visiting the court again after waiting a year for a court date and it still was not scheduled. He saw the Judge at a public event and asked about how to address the delayed court date delayed dilemma as he still has not received written notice. Dr. Mauricio did not ask for the ticket to be dismissed. This occurred during the time when schools were shut down because of COVID 19 and he had the tasks of reconstructing an entire educational system. His focus was on the safety, health, mental wellness and education of students', staff and family. The Board has accepted Dr. Mauricio's explanation of events and that his legitimate inquiry to the Judge was never intended to lead to unethical practice.
